This listing contains information about schools operated by the BIA. Churches, local communities and even the tribes themselves also operated schools, which are not listed here. - **Administrative Files, 1898-1937** This series contains general correspondence, reports, inventories, memorandums, circulars, accounts, contracts, leases, blueprints, telegrams, and other documents sent to and received from the Commissioner of Indian Affairs, Federal officials, and individuals concerning administrative activities such as budget, accounting, and other financial matters; construction; education; personnel matters; equipment; farming; health; heirship; indigent Indians; land allotment, use and sales; liquor suppression; and juvenile offenses. - **Register of Receipts and Disbursements, 10/1/1909-7/31/1917** This series records agency and boarding school receipts and disbursements involving the U.S. Treasury Department, agency and school employees, individual Indians, and vendors of goods and services. Each transaction is placed under one of several funding categories, among which are support of Indians in California, Indian school support, Indian moneys and proceeds of labor, industrial work and care of timber, and pay of Indian police. Balances within each category are brought forward monthly. For each transaction, the date, parties involved, and fiscal quarter and voucher number are also provided. - **Physician's Reports to the Commissioner, 1909-1935** This series consists of copies of quarterly sanitary reports; semi-annual reports for Fort Bidwell School and Agency, Alturas, Likely, and Lookout Day Schools; and weekly and monthly reports of domiciliary patients and outpatients that include names, diseases, number under treatment, degree of Indian blood, deaths, recoveries, treatments discontinued, number of physician's visits, clinics held and their attendance, office calls, and miles traveled. - **Records of Fort Bidwell School Calendar and Programs, 1910-1929** The records include copies of school calendars and daily programs, Likely Day School lesson plans, a report of children eligible for transfer to nonreservation schools, pre-vocational charts, school code, and attendance and enrollment reports. - **Student Case Files, 1910-1931** This series contains medical and dental records, school records, application for admission to nonreservation schools, and related correspondence concerning students' activities while attending and after leaving school. Also included are dental records of Butte School students. (<https://catalog.archives.gov/id/6095000>)

- **Annual Reports, 1911-1925** This series contains narrative and statistical reports. The narrative reports have information on law and order, health, schools, industries, allotments, sales, population, and field irrigation. Statistical reports include tallies of letters sent, Indian marriages, crimes committed, churches missionaries in district, health, births and deaths, diseases, school facilities, industries, agriculture, allotted lands, supplies and equipment, livestock, indigent Indians, field irrigation, and population figures. - **Circulars, 1915-1926** This series contains copies of circulars including information on employees, students, Indian lands, transportation, school costs, contracts, and health matters. Also included are letters sent by the superintendent regarding circulars. (<https://catalog.archives.gov/id/6066144>)
- **Appropriation Ledger, 1917-2/28/1931** This series records agency financial transactions under appropriation headings for various administrative and program activities, such as Indian boarding schools (Fort Bidwell), suppressing liquor among Indians, special deposits of contributed funds, and individual Indian money. - **Correspondence of the Physician-in-Charge, 1929-1939** This series consists of correspondence that concerns agency administration, health program, community projects, and school personnel. Correspondence with Assistant Commissioner J. H. Scattergood regarding the colonization project is also included. (<https://catalog.archives.gov/id/61268599>)

- **Administrative Subject Files, 1907-1926** <https://catalog.archives.gov/id/603475> This series contains correspondence, telegrams, memorandums, circulars, pamphlets, reports, maps and forms relating to education, health, law and order, land allotments, grazing leases, irrigation, the development of agriculture and Indian labor and general economic and social conditions among the Quechan and Cocopah Indians living on the Fort Yuma Indian Reservation. Of particular interest are the management of the Fort Yuma Boarding School and its relationship with other boarding schools such as St. Boniface in Banning, California, the Sherman Institute in Riverside, California and the Phoenix Indian School in Phoenix, Arizona.
- **Records of Receipts and Disbursements, 1909-1918** This series consists of a ledger book containing disbursements of monies and abstracts of property which document, goods and supplies received and distributed by the Fort Yuma Agency. The ledger contains statement of receipts of cash and property and disbursements, expenditures and issues as well as a record of all contracts at the Fort Yuma Indian School. <https://catalog.archives.gov/id/603483>
- **Superintendent's Annual Reports, 1911-1924** This series contains narrative and statistical annual reports for the Fort Yuma Indian Reservation and Indian School in California and the Cocopah Reservation in Arizona (after 1918). <https://catalog.archives.gov/id/603479>
- **Records Relating to the Fort Yuma Indian Boarding School, 1913-1928** This series contains monthly statistical reports of Indian school enrollment, quarterly boarding school reports, annual school calendars, lists of eligible

students for transfer to non-reservation schools, reports on examinations, records of promotions and school attendance registers. Records document names of students, ages, dates of birth, grade, tribe, degree of Indian blood, religion, citizenship status, names of parents or guardians, student attendance, including leaves of absences and desertions, industrial training, and whether students were hired out for work as a part of the outing program. <https://catalog.archives.gov/id/603732>

- **Central Classified Files, 1926-1952** This series contains correspondence, telegrams, reports, circulars, memorandums, vouchers, forms, ration orders, hospital records, and purchase orders. Records document subjects such as land allotments; employment of Indians in emergency conservation and California Emergency Relief Administration projects; agricultural industry, including the growing of cotton and dates; law and order; the admission of U.S. Army soldiers to the Fort Yuma Indian Hospital; and rationing during World War II on the reservation. Also contained in this series are records relating to students from other reservations attending the Fort Yuma Indian Boarding School and Fort Yuma students attending non-reservation boarding schools such as the Phoenix Indian School and the Sherman Institute. <https://catalog.archives.gov/id/603478>
- **Program Management Files, 1960-1963** This series consists of program management files. Topics include student work and educational programs, and water and sanitation programs. Also included are statistical reports. <https://catalog.archives.gov/id/2581396>

- **Quarterly Reports, 1897-1919** This series consists of the following subseries: quarterly reports of arrivals and departures of pupils, 1896-1898 and 1915-1916; quarterly boarding school attendance reports, 1896-1919; monthly school report, 1911; and student attendance registers, 1903-1906. The three student attendance registers document daily attendance during each month of the school year as submitted by Emma H. Paine, teacher; Emma L. Trubody, teacher; and B.B. - **Administrative Description of Government Property, 1897-1911** This series contains reports, statistics and forms regarding the land owned and used by the Greenville School. <https://catalog.archives.gov/id/44009152>
- **Administrative Files, 1897-1923** This series contains correspondence and reports concerning financial affairs; personnel, statistical, and narrative reports to the Commissioner of Indian Affairs; public schools; student enrollment and attendance; allotments; and censuses. Also included are circulars and instructions to superintendents, to employees, and to students. <https://catalog.archives.gov/id/42527678>
- **Superintendent's Outgoing Correspondence, 1898-1923** This series consists of copies of letters sent to the Commissioner of the Indian Office, other superintendents, employees, and vendors. The subjects include routine administrative affairs, construction of a new school building in 1898, the school fire of 1922, and the Fort Belkam Agency. <https://catalog.archives.gov/id/41089305>
- **Outgoing Correspondence of the Superintendents and Clerk-in-Charge, 1916-1922** This series consists of correspondence sent to the Commissioner of Indian Affairs, other superintendents, people in the community,

and various vendors. The subjects include school purchases, Indian allotments and moneys, conditions at the school, building programs, and personnel matters. <https://catalog.archives.gov/id/41089310>

- **Dislocated Administrative Files, 1897-1923** This series contains reports that include descriptions of government buildings, 1897-1906, 1911; articles received, 1898 and 1904; farm statistics, 1904; quarterly reports of school employees, 1896-1902; lists of positions and salaries, 1904 and 1905; school employment reports, 1896-1915 (with gaps); physician's semi-annual reports, 1910, 1911 and 1915; and quarterly sanitary reports of diseases and injuries, 1903 and 1904. <https://catalog.archives.gov/id/42669045>
- **Copies of Superintendent's Outgoing Correspondence, 1898-1923** This series consists of copies of letters sent to the Commissioner of the Indian Office, other superintendents, employees, and vendors. The subjects included are routine administrative affairs, construction of a new school building in 1898, and the school fire of 1922. The first volume, 1875-1895, contains the most detailed narrative description of the receipts and disbursements. Some of the transaction records included payment of wages to white and Indian employees, issues of subsistence rations to Indian families, death of agency stock, sale of hops and beef hides produced at the reservation, and the purchase of agency supplies. The succeeding volumes, 1907-1919, are periodically balanced and the totals brought forward to subsequent accounting periods. Among the transactions recorded are leases and sales of Indian lands.

School visitation forms were completed by the special agent for education during on-site inspections and include notes on such items as verification of student enrollment figures, possible delinquents, student problems, and county reimbursement from the Indian funds. Student classification forms may vary but usually include name, age, grade, degree of Indian blood, IQ levels, and rating of the student's work.

submit reports, and allotments of land to Indian students at off-reservation boarding schools.

- **Individual Indian Check Book Registers, 1905-1917** This series contains registers that typically list account number, check number, date, name on check, voucher number, fiscal quarter, and balance. - **Requests for Authority, 1907-1909** This series consists of copies of correspondence to the Commissioner of Indian Affairs requesting authority to spend money. Also included are some approved authorizations from the Commissioner. Amounts vary from less than \$20.00 to \$3,000 and concern for example, the purchase of electricity, tools, food, medicine, oil, postage stamps, and the employment of laborers at the Sherman Institute, an off-reservation boarding school in Riverside, California. <https://catalog.archives.gov/id/563520>
- **Weekly Reports, 1907-1909** This series consists of one volume of press copies of weekly narrative reports on school related activities. The reports are generally brief, spanning no more than two pages, and cover a myriad of events in the years immediately after the school was established in Riverside, CA. Many of the reports record construction activities and the developments of the school's physical infrastructure. Student activities and events such, athletics, recitals, social events and field trips are also prominent subjects of these reports. - **Individual Indian Money Credit Lists, 1909-1934** This series contains receipts and lists of pupils who were to have their accounts credited. - **Vocational Course Lecture Outlines, 1911-1912** This series includes outlines of classroom lectures in vocational subjects which were intended to help standardize the vocational curriculum in Indian schools. Technical, agricultural and domestic science courses are outlined, including agriculture, electrical, baking, dressmaking, and blacksmithing courses, among others. <https://catalog.archives.gov/id/563546>
- **Records of Boys' Outings, 1912-1918** This series contains ledgers listing the students' names, dates of employment, places of employment, type of work, and the amount earned. - **Athletic Association Records, 1912-1932** This series contains minutes of the association's meetings, lists of athletic award winners and lettermen, notices of future meetings, the Athletic Association's constitution and bylaws, rules for recipients of letters, and appointments of officers. The book also includes one copy of the Sherman Institute "Bulletin" for 1932 which contains an article listing students awarded letterman status. - **Semi-Annual Outing reports, 1914-1930** This series contains reports listing employed male students, amount of time employed, rate of pay, nature of the work, amount earned, wages received, and disposition of the wages (how much was paid to the pupil and how much was deposited in the bank). - **Registers of Receipts and Disbursements, 1915-1918** This series contains registers recording receipts and disbursements from various funds and appropriations. - **Reports on Promotions and Examinations, 1917-1928** This series contains two types of forms from the Office of Indian Affairs. The "Reports on Promotions of Pupils" list school years and statistical data regarding annual enrollments; June enrollments; numbers of students examined, passed condition (i.e. conditionally passed), and failed; percentage passed of those examined; and percentage passed of those enrolled. Each category is subdivided into male or female and by divisions of the school (e.g. primary, prevocational, and vocational). The "Reports on Examinations" list students alphabetically by surname, separately for each class level and sex. For each student the form gives ages; days of attendance; and, by subject, numerical grades for class work, the types of examinations taken, and a grade average received for each examination taken. - **Time/Pay Worksheets for Outing Pupils, 1917-1929** This series contains time and pay worksheets for individual students sent on outings, summer jobs with local families and businesses. - **Central Classified Files, 1925-1939** This series contains correspondence, memoranda, narrative and statistical reports, publications, circulars, newspaper clippings, and other items compiled by the Sherman Institute in Riverside, California. These records concern a wide range of subjects such as budgets, athletics, curricula, education, health and welfare, legislation, personnel matters, purchases of supplies and equipment, statistics, contact with other boarding schools as well as state and local government agencies, and activities of former students. <https://catalog.archives.gov/id/563416>
- **Annual Narrative Report Working Papers, 1927-1931** This series contains draft reports, data concerning school land use, students and their tribal affiliations, attendance, health statistics, campus groups (e.g. Boy Scouts), academic plans, and considerable information regarding items produced and equipment or supplies used in the school's vocational department. The vocational programs includes the harness and auto shops, blacksmith, bakery, laundry, and the school farm. - **Daily Attendance Bulletins, 1928-1929** This series contains forms summarizing the number of students on Sherman Institute campus, the number of students admitted to the hospital, those on the school farm, students participating in the outing program by living and working off campus, and individuals absent without leave. Generally the forms list the names of student who were off campus, including those authorized to attend special off-campus events. The forms also record the actions taken by school officials to locate students who were absent without leave. - **Records Relating to Sylvia Anita Cutler, 1928-1933** This series contains correspondence, court documents, notices, financial statements, bank books, a check register, and account books. - **Commencement Programs and Related Records, 1928-1945** This series includes commencement programs, annual reports, annual calendars, invitations, concert and play programs, and copies of the "Sherman Bulletin." - **Records Concerning Miscellaneous Matters, 1930-1935** This series contains telegrams, lists of students, and correspondence concerning student evaluations and records, school programs, transportation, disciplinary

- **Printed Materials, 1934-1939** This series contains reports, pamphlets, and bulletins detailing Indian land problems and policies, Indian education, legislative news, legislative proposals, and class descriptions and other school information for students. - **Vocational Education Reports, 1936-1941** This series contains the annual narrative reports of the school's vocational departments, including cleaning and tailoring as well as mill and cabinet. A narrative report for the girls' vocational training department is included, as is one for the boys' department. - **Summer School Class Outlines, 1938-1938** This series contains class outlines, a list of the faculty, circular letters for the faculty, and correspondence relating to the summer curriculum at the Sherman Institute. The class outlines include a brief statement of the material to be covered and a full syllabus of the courses along with the teacher's name, education, experience, and references. Some of the subjects included in these outlines are Indian arts and crafts, science, home economics, agriculture, first aid, and health. <https://catalog.archives.gov/id/563548>
- **Student Rosters and Dropout Surveys, 1938-1941** This series contains student rosters as well as dropout surveys. The rosters list students by sex and thereunder alphabetically by surname. A typical entry notes age, class, Indian blood by tribe and degree, home address, Indian agency, and religion. There are also lists titled "NYA Roster" and "Wigwam Roster." The dropout surveys are separated by sex and document all classes from

level eight through twelve. Each lists dropouts alphabetically by surname and gives age, intelligence quotient (IQ), tribe, degree of Indian blood, date of dropping out, address, and remarks concerning the cause for leaving the school. <https://catalog.archives.gov/id/563574>

- **Narrative Reports on Recruiting Tours and Visits to Former Students, 1939-1941** This series contains reports which include travel itineraries and follow-up narratives on former students. The travel itineraries include descriptions of towns and contacts with Indian families. The follow-up narratives on graduates and dropouts consist of a form or photographs and captions that describe what the former students were doing after leaving the Institute. The reports detail visits to northern and southern California as well as the Colorado River Agency in Parker, Arizona. <https://catalog.archives.gov/id/563539>
- **Class Schedules and Related Records, 1939-1942** This series contains schedules and other records documenting daily school and extracurricular activities. The schedules include the overall school daily schedule showing class times, meals, religious services and study sessions, and times allotted to extracurricular activities. Additional schedules show the times for specific extracurricular activities, which include a wide variety of clubs focus on subjects such as arts and crafts, agriculture, cosmetology, Boy and Girl Scouts, and the Junior Lions. Other activities documented in the schedules include student government meetings, the school orchestra, walks and game times. The series also includes some memoranda assigning teachers to oversee extracurricular events and some minutes of Education Committee meetings during which the members discussed the scheduling of special events. <https://catalog.archives.gov/id/563534>
- **Administrative Memorandums and Letters, 1940-1942** This series contains principals' memorandums, letters written by the Education Committee, and files relating to specific employees. The principals' memoranda were directed primarily to the staff and relate to topics such as after-hours assignments, property and school supplies, students and grades, staff meetings, and school activities such as pep rallies and dances. The series also includes a list of athletic lettermen, a list of former students employed in defense industries, and a list of employees from October 1940. The letters by the Educational Committee were directed to students, Indian agents, vendors, and others and concern student and staff referrals, student admissions, students' personal matters, book orders, and supplies, including farm animals. The materials covering employees primarily include summer and weekly work schedules and letters of recommendation. There is also a folder for the nursery school, which contains mainly applications for admission to the nursery. <https://catalog.archives.gov/id/563536>
- **Working Papers Regarding the Constitution of the Student Body Association, 1945-1946** This series contains several versions of the constitution and bylaws of the Student Body Association. Because most of these records are undated, it is difficult to ascertain the drafts from the approved version. Sample versions of the Constitution of the Riverside Junior College and the bylaws of the Fort McDermitt Paiute and Shoshone tribes are also included, as are a few financial reports of the Sherman Institute Associated Student Body. <https://catalog.archives.gov/id/563591>
- **Monthly Statements of the Sherman Institute Store, 1959-1964** This series contains profit and loss statements, lists of expenses, income statements, receipts, reports, ledger sheets, requests for funds, and inventory lists for the student store. - **Vouchers, 1961-1964** This series contains invoices, correspondence, requests for withdrawal of funds, and lists of items purchased. These records document the amounts spent, the accounts from which the monies were drawn, the purchase order numbers, and the reasons for expenditures. Included is information about accounts belonging to the Associated Student Body, classes, or other student groups. The records document the purchase of equipment, supplies, and food for school-related activities. Also included are time and

- **General Correspondence, 1933-1948** This series contains correspondence with the public, students and their families, faculty and staff, and public officials documenting a broad range of administrative and student matters. - **Bank Deposit Records, 1953-1958** This series consists of envelopes containing deposit tickets, receipts, canceled checks, and withdrawal slips. The outside of each envelope contains a ledger showing the running balance of each student's account. <https://catalog.archives.gov/id/563871>
- **Depositor Account Statements, 1961-1965** This series contains bank statements for individuals who deposited money in the Sherman Student Bank. A typical statements shows date, voucher number, reference, debits, credits, and balance. The records document account balances only and do not typically show how students spent their money. <https://catalog.archives.gov/id/603311>
- **Deposit Slips, 1961-1965** This series contains deposit tickets and receipts for individuals who deposited money in their Sherman Student Bank accounts. A typical record shows the amount of the deposit and the date of the transaction. Also included are receipts for collections of money from individuals and businesses for services rendered by Sherman students. - **Records of Withdrawals from Student Bank Accounts, 1961-1966** This series consists of receipts for withdrawals of funds from students' individual Indian accounts maintained by the Sherman School Bank. - **Bank Statements, 1961-1965** This series contains bank statements for the Associated Student Body, teachers' club, and other organizations at Sherman Institute. - **Student Case Files, 1902-1981** This series consists of student case files of Indians from throughout the country who attended Sherman Institute, later known as Sherman Indian High School in Riverside, California. While the information in files varies, most files include the student's name, photograph, date of birth, tribal affiliation, degree of Indian blood, home address and dates of attendance. - **Letters Sent, 1903-1948** This series includes letterpress copies of letters sent by the Superintendent of the Sherman Institute, an off-reservation boarding school in Riverside, California. The letters were sent to government agencies, the public, former students, and students' parents. They cover a range of administrative subjects, including enrollment, transportation of students to and from the school, the health of students, the school's outing program, which sought employment for students in vocational jobs throughout southern California, and the school's budget. <https://catalog.archives.gov/id/563502>
- **Athletic Association Records, 1912-1932** This series contains minutes of the association's meetings, lists of athletic award winners and lettermen, notices of future meetings, the Athletic Association's constitution and bylaws, rules for recipients of letters, and appointments of officers. The book also includes one copy of the Sherman Institute "Bulletin" for 1932 which contains an article listing students awarded letterman status.

- **Recapitulation of Registers, 1919-1929** This series consists of ledgers which summarize the school's accounting data. - **Records of Superintendent Donald Biery, 1932-1949** This series contains letters of appreciation, invitations to speak, records concerning repayment of loans, school matters, and correspondence with friends and colleagues. Included is a December 22, 1942 letter about how World War II affected the school. - **Field Representatives' Correspondence, 1936-1948** This series contains correspondence, applications for admission, reports, and lists of students from various jurisdictions. The records primarily relate to the student outing program, recruitment of students, and placement of graduates. As Sherman Institute enrolled students from various jurisdictions, the Superintendent maintained contact with representatives in charge of student affairs at the local level, among them Lucy Adams, Director of Placement, Window Rock, Arizona; Frank Goldstein, Education Field Agent, Sacramento Indian Agency; Kathryn Mann, Social Worker, Los Angeles, California; J. Preston Myers, Education Field Agent, Hoopa Valley Indian Agency; and John Rockwell, Field Representative in Charge, Sacramento Indian Agency. Mr. Rockwell's file is a continuation of Mr. Goldstein's. Only Lucy Adams' file continued into the post-war period. A 1941 document in the Lucy Adams file relates to the Bureau of Indian Affairs' (BIA) participation in a defense training program. <https://catalog.archives.gov/id/563529>
- **Letters Concerning Students, 1949-1951** This series contains letters and telegrams between the Superintendent of the Sherman Institute, other Bureau of Indian Affairs (BIA) agents and students. The Bureau of Catholic Indian Missions is the largest of three record groups within the Bureau of Catholic Indian Missions Records and the oldest of three affiliated agencies in the Black and Indian Mission Office (Washington, D.C.). Through advocacy and fundraising, the BCIM has supported Catholic evangelization and schools for Native Americans in the United States and dependent territories, 1874-present. Its holdings contain correspondence, reports, photography, publications, audio and video recordings, government documents, and websites, which it created and/or collected.
