THIS INFORMATION CONTRIBUTED GREATLY TO THE LAUNCH OF A LONG-TERM PROJECT AND PARTNERSHIP WITH THE NATIONAL CENTRE FOR TRUTH AND RECONCILIATION (NCTR) OF CANADA TO PRODUCE AN INTERNATIONAL INTERACTIVE DIGITAL MAP. THE MAP INCLUDES ALL KNOWN LOCATIONS OF INDIAN BOARDING SCHOOLS IN THE UNITED STATES, AND ALL KNOWN INDIAN RESIDENTIAL SCHOOLS IN CANADA. THIS HISTORIC PROJECT HAS ALLOWED FOR THE VISUALIZATION OF BOARDING SCHOOL INSTITUTIONS SUCH AS THEIR LOCATION, YEARS OF OPERATION, WHO OPERATED IT, AND A HISTORICAL NOTE. THE INTERACTIVE MAP WILL CONTINUE TO BE UPDATED AND EDITED AS NEW RESEARCH BECOMES AVAILABLE. INCORPORATING THIS NEW TOOL AND THE RESEARCH

COORDINATING WITH TAKODA PREP HIGH SCHOOL IN MINNEAPOLIS, NABS PILOTED A YOUTH INTERNSHIP WHERE STUDENTS ENGAGED WITH NABS STAFF TO PREPARE AND FULFILL 400 CARE PACKAGES FOR BOARDING SCHOOL SURVIVORS. STUDENTS PREPARED BOXES THAT INCLUDED TRADITIONAL MEDICINES, HOME-MADE ITEMS, HAND-WRITTEN NOTES, AND NABS APPAREL, AMONG OTHER ITEMS. STUDENTS ALSO HAD AN OPPORTUNITY TO LEARN ABOUT VARIOUS ASPECTS OF NABS EDUCATION, ADVOCACY, AND HEALING INITIATIVES.

HEARING ON THE U.S. TRUTH & HEALING COMMISSION WHERE NABS LEADERS AND BOARDING SCHOOL SURVIVORS TESTIFIED. IN JUNE 2023, THE BILL WAS AMENDED AND PASSED UNANIMOUSLY OUT OF THE SENATE COMMITTEE ON INDIAN AFFAIRS AND IS BEING PREPARED FOR A FULL SENATE VOTE. IN SEPTEMBER, NABS HOSTED A VIRTUAL CONVERSATION ON THE NEED FOR A U.S. TRUTH AND HEALING COMMISSION WITH SPECIAL GUESTS REP. SHARICE DAVIDS AND CAST AND CREW FROM RESERVATION DOGS. NABS HAS RECEIVED MORE THAN 30 RESOLUTIONS CALLING FOR A TRUTH AND HEALING COMMISSION FROM TRIBAL NATIONS, REGIONAL, NATIONAL, AND INTERNATIONAL ORGANIZATIONS, RELIGIOUS ORGANIZATIONS, AND PUBLIC ENTITIES.

IN JULY, RUTH ANNA BUFFALO, 1ST VICE PRESIDENT OF NABS'S BOARD OF DIRECTORS, REPRESENTED THE COALITION AT THE UNITED NATIONS 16TH SESSION OF THE EXPERT MECHANISM ON THE RIGHTS OF INDIGENOUS PEOPLES HELD IN GENEVA, SWITZERLAND.
